Position: Development Director

Report to: President/Chief Executive Officer

Summary of Responsibilities: The Development Director will provide management and oversight for the public relations, marketing, and fund development functions for the agency. This includes, but is not limited to, the planning, implementation, and evaluation of agency fundraising efforts including donor cultivation and solicitation, recognition, grant writing, oversight and management of agency fundraisers, and partnership development. Additional responsibility includes developing relationships with local broadcast, print and television media and the promotion of all agency activities.

Essential Job Functions:

- Coordinates and oversees the Development operations including Annual Fund Campaign, Special Projects, Bowling Challenge (Bowl for Kids Sake) agency fundraisers, including the annual Bowling Challenge, and third party fund development activities.
- Implements the agency Strategic Plan which includes increasing agency fundraising revenue and continuing to build the agency endowment.
- Responsible for minimum of 5 contacts per week in cultivation, solicitation and stewardship activities.
- Coordinate donor recognition activities.
- Provide written reports to chart progress of Fund Development activities
- Annually review and update Fund Development plan.
- Work collaboratively with the agency management team to develop promotional materials including the Annual Report, Case Statement/Development Brochures, solicitation material and other written correspondence to insure communication with existing and prospective donors
- Develop press releases to promote fundraising events for the agency.
- Research and develop grant application packages and assist with reporting requirements
- Administrative oversight and management of Raisers Edge Donor Software.
- Assist with the recruitment, management, and evaluation of Marketing & Fund Development staff and volunteers. This includes, but is not limited to, professional staff, work study students, interns, and event volunteers.
- Meet the scheduling expectation to serve after regular work hours, evenings, on weekends, and other non-traditional work schedule.
- Have reliable transportation with a valid Michigan Drivers License and automobile insurance.

Other duties as assigned by the President/CEO.

Minimum Qualifications: Bachelor Degree from an accredited college or university with 5 years of professional fund development experience.
